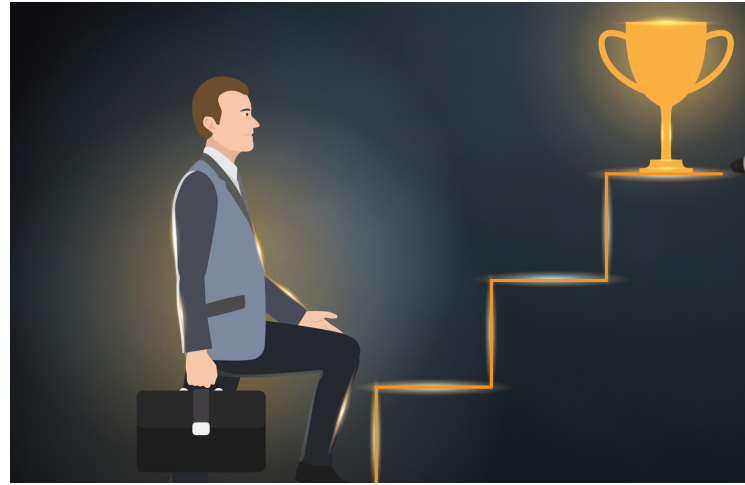
## OUR PANEL OF JUDGES
